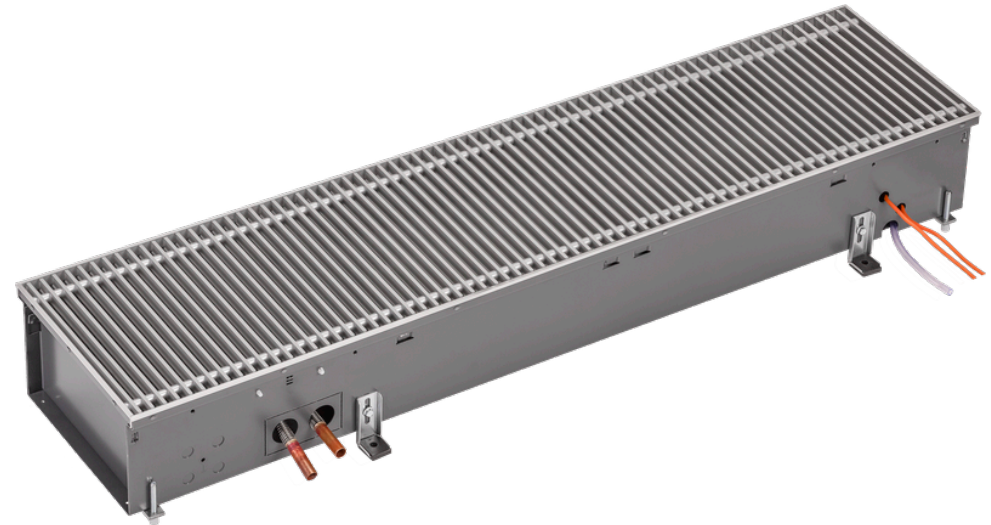

Restriction Notice 1	IR	This impact category deals mainly with the eventual impact of low dose ionizing radiation on human health of the nuclear fuel cycle. Restriction Notice 3	GWP-GHG	The indicator includes all greenhouse gases included in GWP-total but excludes biogenic carbon dioxide uptake and emissions and biogenic carbon stored in the product. This indicator is thus equal to the GWP indicator originally defined in EN 15804:2012+A1:2013
