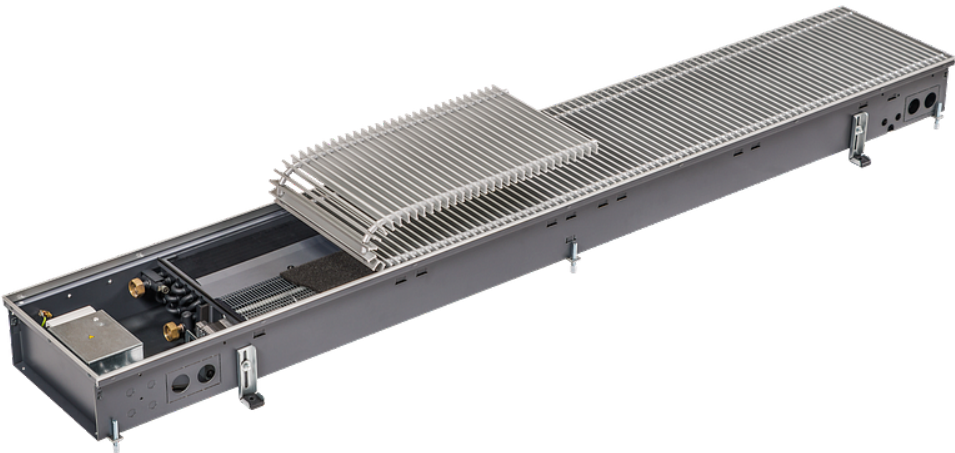

Potential ionizing radiation from the soil, from radon and from some construction materials is also not measured by this indicator.
